## SCHOLARSHIP APPLICATION

**Applicants** must be graduating high school seniors with plans to undertake a career in physical education or related field (athletic trainer, physical therapy, etc.) **Two** scholarships will be awarded annually, one each to a boy and a girl. The amount of each scholarship will be determined by the Trustees of the Roger J. Sheridan Memorial Trust Fund but will be in excess of \$500.00.

The scholarships are for one (1) year only and are conditioned upon the enrollment of the student in an accredited American College or University. Upon receipt of enrollment from proper officials, a check for the awarded amount will be forwarded to the college or university to establish credit for the student.

### GENERAL INSTRUCTIONS

#### **ALL APPLICATIONS SHOULD INCLUDE:**

1. Official signed transcript of high school grades.
2. A copy of SAT or ACT scores.
3. Current dated, signed, one (1) page letter of recommendation from a person in authority from high school attended by student.
4. Current dated, signed, one (1) page letter of recommendation from a coach or athletic director from high school attended by student.
5. A statement from the parents/guardians summarizing the family's obligations and resources.
6. An essay from the applicant stating their plans after graduation from college.

**Note:** All applications must be typewritten and all questions answered. Applications are due **no later than February 1<sup>st</sup>** at the local Elks Lodge (Brattleboro Elks Lodge at 75 Putney Road).
