During Athletics and Co-Curricular activities review, S. Kilelee, Athletic Director, shared guidelines set in place for COVID- 19 return to sports. S. Kilelee explained to the Board that NHIAA had not given much guidance, and schools are coming up with their safety guidelines and policies for sports. S. Kilelee shared Hinsdale District Return to Sports plan which included, wearing masks on the busses and in buildings. Riding in separate buses will be arranged if need to allow spacing.

Along with face masking and a minimum three-feet distancing requirement, the plan included quarantine requirements if a student tested positive, details about assessing student academic needs, including after school tutoring, and individual basis attention to identify "learning gap" due to pandemic.

W. Woolridge shared with the Board unless the positivity rate gets higher and the schools need to be close, the schools will not provide remote classes, and students will be required to be in school in person.

A. Freitag explained to the Board, if a student needs to stay home because of sickness or quarantine, the student will have two days for each missed school days to make up work, and school work packets can be received while the student is out.

Administrators and teachers are developing "pivot plans "in the event the district must switch to remote learning.

Questions were asked and answered while reviewing each category section for a reopening plan. After discussion
