Review of Policy EBGC	The committee had requested to have EBGC included in the packet as it was referred to in Policy JLCG-R. The committee wanted to make sure that nothing in JLCG-R would conflict with the changes being proposed to the three policies being worked on. We quickly reviewed to ensure we wouldn't be in opposition to policy EBGC.
