2. Reviewed the proposed changes from the attorneys.

- 1 - Agreement to Send and Receive Students. Discussed students attending the public charter schools. They are not included in the 80%. All agreed to the changes.
- 4b(i) – Special Education Expenses. Do not limit to Medicaid. Hinsdale’s IEP team shall control. All agreed to the changes.
- 4d(i) – Capital Costs. All agreed to the changes.
- 7 – Career and Technical Education. All agreed to the change (spelling out CTE).
- 11 – Enrollment Schedule and Minimum Tuition Calculation. All agreed to the changes.

3. 4b(iii) - Special Education Expenses. All agreed to omit the last sentence.

4. Discussed the postings and public hearings.
